OFFICIAL RULES

NEITHER ATTENDANCE AT THE ADHA25 ANNUAL CONFERENCE NOR PURCHASE IS NECESSARY TO ENTER OR WIN. ATTENDING THE ADHA25 ANNUAL CONFERENCE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ENTRIES RECEIVED. VOID WHERE PROHIBITED BY LAW. ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

1. Eligibility. This giveaway (the “Promotion”) is open only to legal residents of the United States (not including residents of Florida, California and New York). Only individuals who are at least eighteen (18) years of age or older (except, in the case of legal residents of certain states where the legal age of majority is greater than eighteen (18) years of age, such legal age of majority) at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child, sibling, and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of the American Dental Hygienists’ Association (the “Host”) and any and all companies associated with the Promotion are not eligible to participate or win the Prizes (as defined below). Eligibility is also contingent upon compliance with these Official Rules and fulfilling all requirements set forth herein. The Promotion is subject to all applicable federal, state, and local laws, rules, and regulations. Void in Florida, California, New York and where prohibited or restricted by law, rule, or regulation.

2. How to Enter. The Promotion begins on June 1, 2025, at 12:01 A.M. Central Time (“CT”) and ends on June 30, 2025, at 5:00 P.M. CT (the “Promotional Period”). You may enter the Promotion by either of the methods described below. No other method of entry will be accepted. Each individual is limited to only one (1) Entry. If you enter using both methods of entry set forth below, such that you have more than one (1) Entry to the Promotion, you will be disqualified from and deemed ineligible to participate in the Promotion. Entries under either method must be **received** by the Host prior to the conclusion of the Promotional Period.

- **Registering for the ADHA 25 Annual Conference.** Individuals who are eighteen (18) years of age or older that register to attend the ADHA 25 Annual Conference, which will be held October 4 – 6, 2025 at the Long Beach Convention Center, in Long Beach, California (the “Event”) will automatically be entered in the Promotion (unless they opt-out). Entrants must complete the registration form in its entirety and provide all required information (including, without limitation, their full name; email address; cell phone number, day and/or evening telephone numbers (including area codes), state of legal residence, and physical address).
- **Housing with Hyatt Regency Long Beach.** Individuals who are eighteen (18) years of age or older that book their stay at Hyatt Regency Long Beach with the intention to attend the ADHA 25 Annual Conference, will automatically be entered in the Promotion (unless they opt-out). Entrants must complete the registration form in its entirety and provide all required information (including, without limitation, their full name; email address; cell phone number, day and/or evening telephone numbers (including area codes), state of legal residence, and physical address).

Individuals entering the Promotion using one of the methods of entry described above will each receive one (1) “Entry” and are referred to herein collectively as “Entrants” and each individually as an “Entrant.”

3. Random Drawing/Winner Selection. On or about June 30, 2025 (the close of the Promotional Period), the Host will select up to (2) winners at random from amongst all Entrants as detailed below (“Preliminary Winners”). Subject to verification of eligibility and compliance with the terms of these Official Rules, the Preliminary Winners will be declared the official winners of the Promotion (the “Winners”). 5. Prize Conditions. All Prize details will be determined in the sole and absolute discretion of the Host. Except as otherwise specifically set forth herein, all costs and expenses associated with acceptance of a Prize and use thereof, including, but not limited to, any lodging, transportation, shipping, postage, delivery, meals and beverages, gratuities, data plans, taxes, warranties, and other expenses incurred by or in connection with acceptance and use of a Prize are the sole responsibility of the Winner. 6. Winner Determination, Verification and Notification. A Prize Notification will instruct each Preliminary Winner that they must reply to such Prize Notification within a specified time period and follow all instructions contained therein in order to claim their Prize. Instructions include, but are not limited to, providing all additional information requested by Host in order to confirm eligibility and signing/returning (except where prohibited by law) an “Affidavit of Eligibility,” a “Liability & Publicity Release,” and a W-9 tax form (if required by law) which requires disclosure of the Preliminary Winner’s social security number (collectively, the “Documents”) by a specified date. All Preliminary Winners must have complied, and must continue to comply, with all terms and conditions of these Official Rules; eligibility is contingent upon fulfilling all requirements set forth herein. If a Winner or Preliminary Winner is or becomes ineligible for any reason, disqualification will result. At the Host’s sole discretion and time permitting, the Host may select an alternate Preliminary Winner at random from among remaining eligible Entrants, and such alternate Preliminary Winner will be subject to the same verification of eligibility and compliance requirements as the initial Preliminary Winner.

Except where prohibited, Entrant agrees that this Promotion and these Official Rules and any action or omission relating to or arising out of this Promotion is governed by the laws of the State of Illinois, without regard to the conflicts of law provisions, and is subject to the laws, rules, and regulations of the United States and these Official Rules. As a condition of participating in this Promotion, participants agree that any and all disputes which cannot be resolved between the parties and causes of action arising out of or in connection with this Promotion, will be resolved individually, without resort to any form of class action, exclusively before a court located in Chicago, Illinois having jurisdiction, and participants submit to the jurisdiction of the courts located in Illinois. Further, in any such dispute, under no circumstances will participants be permitted to obtain awards for, and hereby waive all rights to claim, punitive, incidental, or consequential damages, including attorneys' fees, other than participant's actual out-of-pocket expenses (e.g., costs associated with Entry), and participant further waives all rights to have damages multiplied or increased.

12. Entrant's Personal Information.
