





# Secure an Accredited Symposium

Accredited Symposia<sup>1</sup> (AS) are showcased and highly anticipated sessions at the CCC 2024. A 60-minute lunch hour session is included in the Scientific Program, extending the delegate's educational experience, bringing key thought leaders and the latest research to the forefront. AS are a great opportunity to get input and feedback directly from clinical decision makers.

Accredited Symposia are co-developed and accredited by the CCS for Royal College of Physicians and Surgeons of Canada (RCPSC) MOC Section 1 credits and American Medical Association PRA Category 1 credits, as well as ECMEC® and QCHP Category 1 credits.

- All AS at the CCC 2024 will be delivered live on site during a 60-minute lunch hour timeslot. An AS will only be slotted against other AS programs without overlap in topic or content.
