Our strategic direction has never been clearer and our staff never more capable!

#### **Education Supports COVID Resource Requests**

To reflect on something that has affected all our lives, I hope you took advantage of the IECA resources created for you to weather the storm. From surveys to learn how our members were being affected, prepping workplaces for going into quarantine and providing updates from the EPA on compliance while in quarantine, to leadership videos reaching out to members, free education to thrive in COVID and moving regional events online allowing membership to also attend for free. This move to an online environment allowed IECA and our chapters to host 24 virtual events featuring 98 live and on-demand programs on regionalized problems and COVID-related solutions.

On the skirts of lockdown, we were able to hold the IECA Annual Conference and Expo in Raleigh, North Carolina. Our last in-person event was highlighted with sell-out field tours (an IECA first), an onsite rainfall simulator to showcase water filtration improvement and new recognition for IECA members in the industry. New award categories recognized Three Young Professionals Under 30, Four Young Professionals Under 40 and sustained IECA partners. We have increased our efforts to recognize those contributing members in our industry.



**Promote** – Expand awareness of IECA's impact on erosion, soil and water.


**Lead** – Lead a powerful global association to serve the industry and society.

I believe this approach to our strategic plan gives our chapters a clear path to align their efforts while giving guidance to our members that will ensure our successful future!



### Reunification
