

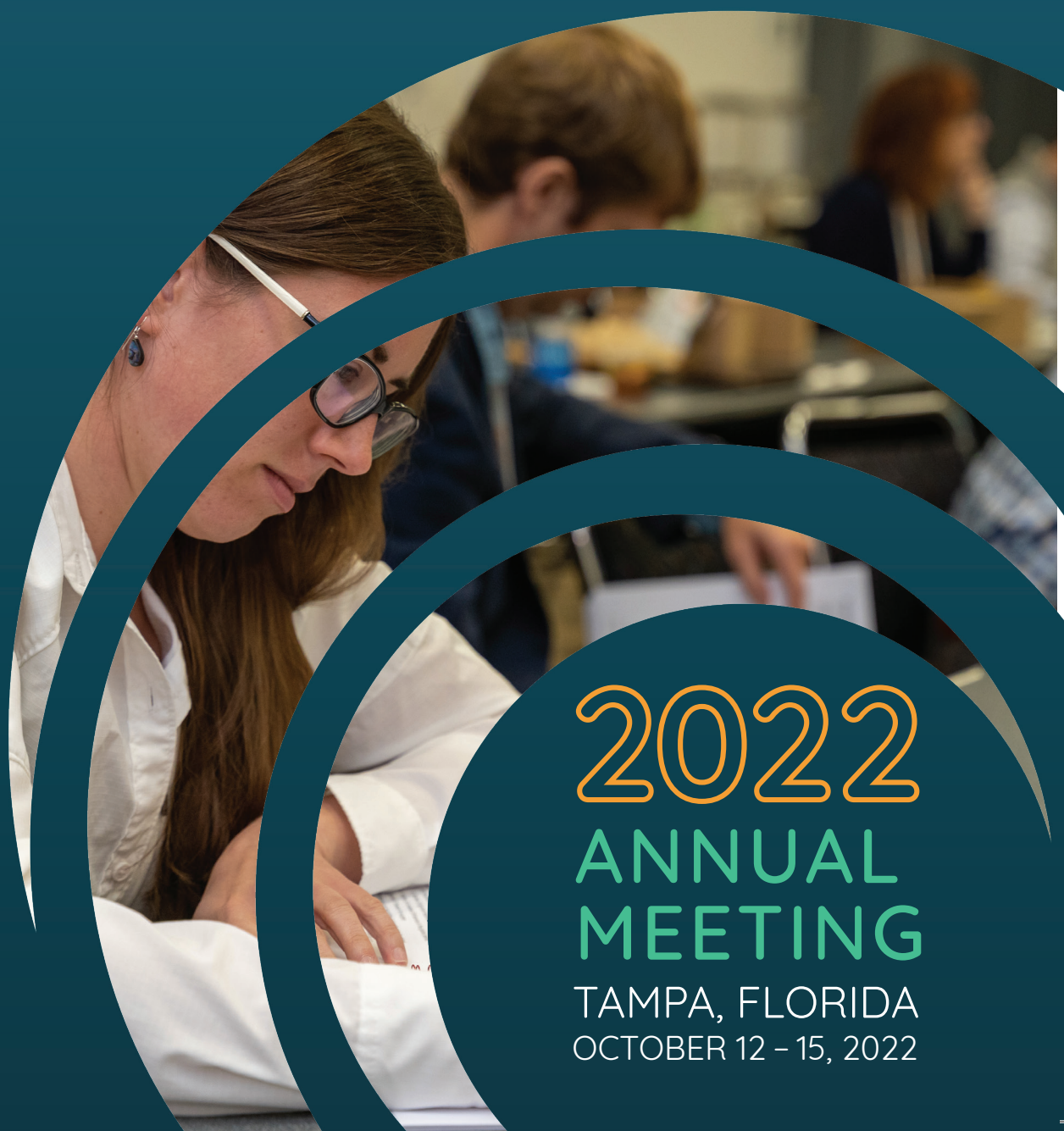

OVERVIEW

Sarah Wiskerchen from KarenZupko & Associates, Inc will lead attendees through essential coding subjects for trauma surgeons. Beginning with E/M services, she'll review common questions and answers about how the 2021 criteria are defined, and variations that apply in different practice settings. Importantly, she'll explain how E/M criteria for consultations, inpatient services, and observation will change in 2023, and how CMS's shared visit reporting rules for physicians and PAs/NPs will be revised. For surgery, she'll explain important changes in Fracture care reporting and arthroplasty coding, as well as associated services such as external fixation, hardware removal, NWPT, and drug delivery devices. We'll integrate these concepts in practical, real-world trauma scenarios, addressing commonly-asked questions about when services can (or can't) be separately reported under CPT rules.
